SUBJECT: Delegation of Authority for Joint NOAA and NASA Mission Acquisition Strategy

and Program Management

This memo clarifies and expands upon the prior Associate Administrator memo of June 26, 2018, which was limited in scope to programmatic decision authority.

Joint National Oceanic and Atmospheric Administration (NOAA) - National Aeronautics and Space Administration (NASA) missions fall under the governance structure, appropriation authority, and programmatic decision authority of NOAA. NASA is responsible for the development (formulation and implementation) of the missions and serves in a supplier role to NOAA.

- (1) Delegation of Authority for Joint NOAA and NASA Agency Program Management Council Decision Memoranda and NOAA and NASA Agency-level Documents. The 2018 memo delegating this authority is reaffirmed and incorporated in its entirety into this NASA Policy Instruction (see enclosure). Signature authority of the Associate Administrator is reserved for when decisions are raised from the NOAA to the Department of Commerce level, unless otherwise delegated on a case-by-case basis.
- (2) Convening Authority for Acquisition Strategy Meetings. Convening Authority for Acquisition Strategy Meetings is delegated to the Science Mission Directorate (SMD) Associate Administrator. As a supplier to NOAA, rather than programmatic authority, acquisition risks to NASA are likely to be institutional, e.g., overall capacity issues with performing NASA Centers. SMD is the correct Convening Authority to assess, manage, and/or accept such risks.
  - When SMD chooses to convene an Acquisition Strategy Meeting, it will be a joint meeting with NOAA National Environmental Satellite, Data, and Information Service (NESDIS) resulting in a recommendation for approval by NOAA.
  - SMD should submit relevant Joint Agency Satellite Division (JASD) missions in pre-formulation to annual Agency acquisition forecasts for purposes of awareness and procurement planning.
  - For exceptionally large commitments, the Associate Administrator may, upon consultation with the Associate Administrator for Science Mission Directorate,

- request an antecedent Decision Framing Meeting at the Acquisition Strategy Council to discuss capacity impacts or other issues.
- SMD will follow requirements in NASA Advisory Implementing Instruction (NAII) 1000.2, Acquisition Strategy Meeting Guide, for all delegated Acquisition Strategy Meeting decisions.
